#### Rate cut likely amid low inflation, IMF review

KARACHI: Most analysts predict a seventh consecutive rate cut by Pakistan's central bank on Monday, amid the country's first International Monetary Fund (IMF) review for its \$7 billion bailout and near-decade low inflation.

#### PM apprised of challenges facing businesses

#### FBR introduces major changes to EFS

KARACHI: The Small and Medium Enterprises (SMEs) are forced to run their businesses with an unregistered title due to what the Karachi Tax Bar Association (KTBA) claimed "virtual halt in fresh registration of taxpayers under the Sales Tax Act, 1990" by the FBR.

## Nepra gives FCA cut benefit to residential, agri consumers

ISLAMABAD: National Electric Power Regulatory Authority (Nepra) has passed reduction in tariff through negative Fuel Charges Adjustment (FCA) to all non-protected residential and agriculture consumers.

KARACHI: To ensure enhanced security with the rising digitisation of the financial system, the State Bank of Pakistan (SBP) has decided to transition from web-based to Virtual Private Network (VPN)-based access from May 30.

#### Weekly inflation falls 0.87pc

ISLAMABAD: Short-term inflation, measured by the Sensitive Price Index (SPI), recorded a negative growth of 0.87 per cent year-on-year in the week ending March 6 after almost seven years owing to a decline in the retail price of tea and perishable products.
