# VIRTUAL PUBLIC HEARING NOTICE

## APPLICATION FOR GRANT OF LICENCE BY K-ELECTRIC LIMITED, KARACHI FOR CONSTRUCTION AND OPERATION OF A TRANSMISSION PIPELINE

K-Electric Limited, Karachi (KEL) (the applicant) has applied under OGRA's Natural Gas (Licencing) Rules, 2002 for grant of license for Construction and Operation of a Transmission Pipeline. KEL is a subsidiary company of KES Power Limited. The applicant has commenced construction of this power station as BQPS (III) (900 MWCCPP) in its Bin Qasim Power Complex in Karachi to serve the electricity needs of Karachi and adjoining areas. To fuel the same, in accordance with the decision of the Cabinet Committee on Energy (CCOE), K-Electric will take delivery of allocated gas from PLL from the tie-in point at SSGC network within the boundary of Custody Transfer Station and this tie-in point will be situated immediately downstream of the battery limit of FOTCO's pipeline.

K-Electric is to lay this pipeline which will handle RLNG supply up to 250 (MMSCFD) at 85 bar pressure 14-inch diameter transmission line tie-in points to its facility through this project.

After completion of the requisite data / information by the applicant, the Authority has admitted the instant application and issued notice of public comments in leading newspapers on 06-11-2020. Now, due to 2nd massive wave of Pandemic/COVID-19 outbreak throughout the country, OGRA has decided to hold the virtual Public Hearing which will be conducted through **Virtual / Zoom Application on 25-11-2020 at 11:00 am in OGRA Office, Islamabad.**

Therefore, to save the public from COVID-19 risk, the interested persons / stakeholders / general public can attend the same through Virtual Public Hearing / Zoom Application.
