**7. General conditions of participation in the Show**
**1. Organizer**

**2. Registration**

To be admitted to the Fair, an Exhibitor should submit a fully completed Contract-Application form for the Fair. The Exhibitor shall affix his/her legally binding signature to the Contract-Application form and send the form to the Organizer prior to the deadline for application indicated in the Contract-Application form. The registration is valid for the time of the Fair indicated in the Contract-Application form. The original of the Contract-Application form is to be handed to the Organizer by post.

**3. Terms of payment; unilateral refusal to perform the contract in case of non-payment and insolvency**

- 3.1. Along with confirmation of participation in the Exhibition, an invoice is sent. All established prices are increased by value added tax at the rate established by the current tax legislation. Russian Exhibitors pay invoices in Russian rubles. Foreign Exhibitors pay all invoices in euros, Russian rubles or US dollars.
- 3.2. 100% of the invoiced amount is due at 5 working days after receiving Invoice, unless otherwise set out by the Organizer in the blank Contract-Application form. The payment shall be made in such a manner that the respective amount would be credited to the Organizer' accounts without any additional costs thereto and in due time. All the banking commissions are to be paid by the exhibitor (participant).

**4. Participation in the Fair.**

Within the framework of participation in the Fair, the Exhibitor undertakes to fill in the relevant information about himself in the personal profile of the specially designed online platform. In case the data are not filled in by the Exhibitor at least one week before the opening of the Exhibition, in order to ensure the completeness of the catalogue, the Organizer has the right to include the data about the Exhibitor in the catalogue based on the data available to the Organizer, including the data specified in the Application Form or the data of the last Fair catalogue, and is not responsible for the correctness of such data.

**5. Indemnity and liability for non-participation, forfeitures, unilateral refusal to perform the application form.**

- 5.1. If, registered and admitted to participate, the Exhibitor refuses to participate in the Fair, the Exhibitor shall be liable for refusal of this contract regardless of the reasons for its non-participation. If the Exhibitor cancels this Contract at the initiative of the Exhibitor, not related to the improper performance of its obligations under this contract, less than 1 month before the date of the Fair, the Organizer shall deduct 100% of the amount invoiced to it on the basis of the Application Form.
- 5.2. The Exhibitor is in any case responsible for paying the participation fee. In case of failure to pay the invoice by September 1, 2020, the Organizer shall have the right to terminate this Contract and collect from the Exhibitor the

incurred and documented costs, as well as penalties at the rate of 0.1% of the outstanding amount for the period of delay from the date of expiration of the payment term to the date of termination of this Contract.

- 5.3. In case of violation of one of the abovementioned duties, the Organizer may deny the Exhibitor access to future Fairs. In this case, the Exhibitor shall not be entitled to claim damages.
- 5.4. Exhibitors who have paid the participation fee in full and/or have debts for previous Fairs, the Organizer has the right to stop from the participation in the exhibition at its own discretion.
- 5.5. The refusal to fulfill the Contract is understood as a complete refusal to fulfill the Contract.
- 5.6. The start date of the Fair is understood to be the first day of the exhibition.

#### 6. Protection of data

- 6.1. With the respect to the personal data collected by the Exhibitor during the Fair or received by the Exhibitor from the Organizer, the Exhibitor shall respect confidentiality of such data and not disclose the data to third parties, except as otherwise specified by the law. The Exhibitor shall also ensure the security of personal data during their processing and comply with the principles and rules of personal data processing in accordance with Federal Law No. 152-FZ dated 27.07.2006 "On Personal Data".
- 6.2. The Organizer reserves the right to demand from the Exhibitor termination of unlawful processing of personal data indicated in paragraph 1.21 (2) above. In such a case the Exhibitor shall terminate data processing within 5 business days from the date of receipt of the Organizer's demand in the written form.
