Industrial consumers : PLL, SSGC may be allowed to auction off unutilized capacity of LNG

ISLAMABAD: The government is likely to allow Pakistan LNG Limited (PLL) and Sui Southern Gas Company (SSGC) to auction operationally-possible unutilized capacity of LNG to industrial consumers for a specified period and quota to be determined by the Petroleum Division, considering the socioeconomic agenda of government of Pakistan (GoP), downstream demand and plan of LNG imports, well informed sources told Business Recorder.

Rs7.50 per unit hike in basic power tariff okayed by Nepra

Govt refuses to budge on power tariff hike

ISLAMABAD: Despite strong opposition from consumers, the power division and the power regulator did not budge from increasing national uniform electricity tariff by up to 26pc (Rs7.5 per unit) with effect from July 1, 2023 as committed to the International Monetary Fund (IMF).

Tax clearance mandatory for property transactions

ISLAMABAD: The Federal Board of Revenue (FBR) has issued guidelines on tax payment for property sellers and transferors aimed at simplifying property transactions and ensuring tax adherence.

45-day limit set for resolution of tax disputes

ISLAMABAD: The government has made it mandatory for the Federal Board of Revenue (FBR) to resolve tax disputes within 45 days. KARACHI: The rupee suffered its seventh consecutive loss against the dollar, depreciating by Rs1.11 in the interbank market on Monday, despite claims of stability and high hopes with the IMF inflow.

Power tariff raised due to IMF conditions, says PM Shehbaz

LAHORE: Prime Minister Shehbaz Sharif has said the government has raised the electricity tariff because of the tough IMF conditions, but added that 63 per cent of the domestic consumers using up to 200 units per month would be exempted from the power tariff increase.

Pakistan ranked third in the world for imposing internet restrictions

KARACHI: Pakistan has been ranked third in the world over the imposition of internet restrictions in the first half of 2023. According to a report by Surfshark, a virtual private network company headquartered in Lithuania, a half-year analysis of internet shutdown based on the Internet Shutdown Tracker reveals that Pakistan was responsible for three of the 42 new restrictions worldwide, which were imposed following the arrest of former prime minister Imran Khan on May 9.
