Tax exemption on POL products: FBR suffers massive revenue loss in 2022-23

ISLAMABAD: The Federal Board of Revenue (FBR) has suffered revenue loss of Rs 1.25 trillion during 2022-23 on account of sales tax exemption granted to the petroleum products, according to the new Tax Expenditure Report-2024.

FY24: forex reserves record increase of over \$5bn on foreign inflows

KARACHI: The country's total liquid foreign exchange reserves recorded an increase of over \$5 billion during the last fiscal year (FY24). According to the State Bank of Pakistan's statistics, Pakistan's foreign exchange position has improved during the last fiscal year supported by arrival of inflows from the international financial and multilateral agencies.

'Unjust' budget: MoC, exporters join the chorus against MoF, FBR

ISLAMABAD: The Commerce Ministry and exporters on Thursday joined the chorus against Finance Ministry and Federal Board of Revenue (FBR) for an 'unjust' federal budget tailored in consultation with the International Money Fund (IMF), as it will hit exports.

Discos' consumers: Nepra set to hold hearing to put its stamp on revised SoT

ISLAMABAD: The National Electric Power Regulatory Authority (NEPRA) is all set to hold a public hearing to put a stamp on modified Schedule of Tariff (SoT) for consumers of Discos proposed by the Power Division on July 8, 2024, to increase domestic consumers tariff by Rs 7.12 per unit sans lifeline consumers, as government has alerted NEPRA's original determination on base tariff revision after talks with the IMF.

THE RUPEE PKR registers marginal decline against USD

KARACHI: The Pakistani rupee registered a marginal decline, depreciating 0.04% against the US dollar in the inter-bank market on Thursday. At close, the local unit settled at 278.50, a decline of Re0.10 against the greenback, according to the State Bank of Pakistan (SBP).

Shortage of petrol likely at some places

ISLAMABAD: People may face a shortage of petrol in some places in the country following a countrywide strike on July 5 (Friday) against the imposition of advance tax in the budget for 2024-25.

Group of fuel dealers rejects today's strike

KARACHI: A group of petroleum dealers have announced they will not join the July 05 strike. These petroleum retailers have said that they will take the path of detailed negotiations with the authorities before opting for extreme options like an indefinite strike.

SSGC announces 24-hour gas holiday on 7th

KARACHI: Sui Southern Gas Company (SSGC) has announced 24-hour gas holiday for all industries including their power generation units and all CNG stations in Sindh from 08:00 am on Sunday, July 07. Due to the

shortages of gas supplies in SSGC's system, the availability of gas has decreased, resulting in the depletion of line pack, causing low pressures in the system, the SSGC said.

Aurangzeb, other ministers to visit FPCCI's regional office

LAHORE: Federal Minister for Finance & Revenue Senator Muhammad Aurangzeb and Minister of State for Finance, Revenue & Power Ali Pervaiz Malik will visit the Federation of Pakistan Chambers of Commerce and Industry (FPCCI) Regional Office Lahore on Saturday, July 06, 2024.

Modest activity on cotton market

The rate of Phutti in Sindh is in between Rs 8,300 to Rs 8,700 per 40 kg.

ISLAMABAD: In a bid to unlock the IMF programme of over \$6 billion, the government has taken another prior action by increasing the applicable end-power tariff of protected consumers by up to 51 per cent and unprotected consumers by up to 43pc from July 1, 2024.
