#### Pakistan's current economic model is not working: World Bank

ISLAMABAD: Pakistan's current economic model is not working since it has fallen behind its peers, significant progress in poverty reduction has now started to reverse, and the benefits of growth have accrued to a narrow elite, observes World Bank Country Director Najy Benhassine.

## T-bill auction raises four times more than target

KARACHI: The cash-starved government raised almost 300 per cent more than the target through the auction of treasury bills on Wednesday, reflecting a widening gap between revenue collection and its ever-rising expenditures.

#### **Dollar outflow plunges**

KARACHI: The repatriation of profits and dividends on foreign investments plunged to just \$46.8 million in November against the first four months' average of \$120m, reflecting restriction on dollar outflows amid falling foreign exchange reserves.

#### Oil price drops 1pc

NEW YORK: Oil prices dropped over one per cent on Wednesday, eating into the previous day's gains as investors monitored developments in the Red Sea, where shippers are returning despite further attacks on Tuesday.

#### Power consumers to face Rs4.66/unit hike in Jan bills

ISLAMABAD: Consumers are poised to confront another surge in electricity prices, reaching up to Rs4.66 per unit in the January 2024 electricity bills, attributed to the fuel adjustment for November. The proposed increase, if implemented, would impose an additional burden of Rs33 billion on power consumers.

## ENI confirms LNG cargo in January after initial doubt

ISLAMABAD: Pakistan, which is facing a severe gas shortage that has crippled its power sector and industries, will receive a liquefied natural gas cargo from Italy's ENI SpA on Jan. 18 as scheduled, averting a potential supply disruption, government offcials said on Wednesday.
