SMEs come under sharper govt focus

ISLAMABAD: Prime Minister Shehbaz Sharif on Monday called on relevant institutions to expedite efforts to ensure that banks and financial institutions offer more accessible loans to small and medium-sized enterprises (SMEs), following concerns over the challenges faced by the sector.

APTMA urges Ogra to review RLNG actual sales price for 2015-22

LAHORE: APTMA has approached OGRA seeking rehearing for determination of RLNG actual sales price for the period 2015 to 2022 primarily on Grounds of UFG Misallocation and Non-Disclosure of the Computation Trail. APTMA has pointed out that over the 84-months actualization period; around 47 million tonnes of LNG was consumed.

Super tax case: Rs114bn collected in terms of Sec 4B of IT Ord, FCC told

ISLAMABAD: The Federal Constitutional Court was informed that Rs114 billion were collected in terms of Section 4B of the Income Tax Ordinance, while the federation spent Rs117 billion, from its sources, on the rehabilitation of the temporarily displaced persons (TDPs).

LESCO overbilling cases: AGP restrains FIA from initiating probe

ISLAMABAD: The Auditor General of Pakistan has asked the Federal Investigation Agency to refrain from initiating inquiries into overbilling cases without prior technical validation and to coordinate with the Nepra and the Provincial Office of Inspection.

FBR imposes penalty on RTO tax official

ISLAMABAD: The Federal Board of Revenue (FBR) has imposed a major penalty on a tax official of Regional Tax Office (RTO), Lahore for deleting CCTV footage of stealing of 20 cartons of cigarettes from the premises of the office, said a notification issued here on Monday.

ISLAMABAD: The Federal Board of Revenue (FBR) has again reconstituted committee to evaluate applications for grant of licence for integration of registered persons under the Sales Tax Rules, 2006. In this regard, the FBR has issued a notification here on Monday.

THE RUPEE PKR: improvement

KARACHI: The Pakistani rupee reported marginal improvement against the US dollar in the inter-bank market on Monday. At close, the local currency settled at 280.10, a gain of Re0.01 against the greenback. During the previous week, the Pakistan rupee welcomed 2026 with another gain as it appreciated by Re0.06 or 0.02% against the US dollar in the inter-bank market.

Gold, silver prices jump

KARACHI: Gold prices posted huge gains with silver rising sharply on Monday, tracking a global uptrend, traders said. A big surge in world market rates pushed up local gold prices by Rs9,200 to Rs464,762 per tola and Rs7,888 to Rs398,458 per 10 grams, APSGJA said.

Sell-side due diligence begins for five power utilities as advisers step in

ISLAMABAD: Pakistan has stepped up preparations to privatize five state-owned power distribution companies as financial advisers have already begun sell-side due diligence, a key milestone tied to commitments under the International Monetary Fund bailout program, official documents showed Monday.

Gas supply improves this winter, says petroleum minister

ISLAMABAD: With winter demand at its peak, Petroleum Minister Ali Pervaiz Malik on Monday reviewed the country's gas supply situation and winter load management measures, expressing satisfaction over improved gas availability for domestic consumers compared to last year.

Furnace oil exports hit 778,000 tonnes in H1 FY26

KARACHI: Pakistan exported 777,687 metric tonnes of furnace oil during the first half of the current fiscal year FY26, driven by weak domestic demand. Data shared by the oil sector with The News shows that the country exported 137,500 metric tonnes of furnace oil in December alone, as refineries moved to dispose of rising inventories amid sharply reduced local offtake.
