#### Salaried individuals: FBR issues 'frivolous' tax recovery notices

ISLAMABAD: The Federal Board of Revenue's field formations have issued frivolous tax recovery notices to the salaried individuals to generate additional revenue and raise illegal tax demands against the already overburdened salaried class.

### Mian Zahid holds IMF responsible for economic slowdown

The Chairman of National Business Group Pakistan, the President of the Pakistan Businessmen and Intellectuals Forum, the President of All Karachi Industrial Alliance, the Chairman of the FPCCI Advisory Board, Mian Zahid Hussain said in the past decade ongoing political confrontation and revenge politics have left the country politically and economically unstable.

### **THE RUPEE PKR: marginal improvement**

KARACHI: The Pakistani rupee saw marginal improvement against the US dollar, appreciating 0.02% in the inter-bank market on Wednesday. At close, the currency settled at 278.87 for a gain of Re0.06 against the greenback, according to the State Bank of Pakistan (SBP). The rupee had closed at 278.93 on Tuesday.

### Gold prices regain momentum

KARACHI: Gold made a significant recovery on Wednesday as the global market regained momentum, traders said. Up by Rs2,300 and Rs1,972, gold prices scaled up to Rs288,700 per tola and Rs247,513 per 10 grams, respectively, according to All Pakistan Sarafa Gems and Jewelers Association.

## Spot rate loses Rs200 per maund

LAHORE: The Spot Rate Committee of the KCA on Wednesday decreased the spot rate by Rs 2,00 per maund and closed it at Rs 18,000 per maund. Cotton Analyst Naseem Usman told Business Recorder that the local cotton market remained bearish and the trading volume remained low.

## Don't take GSP+ for granted, warns EU envoy

ISLAMABAD: The European Union has warned Pakistan not to take its GSP+ status for granted. Olof Skoog, the EU Special Rep-resentative for Human Rights who is currently on a week-long visit to Pakistan, has also urged the government not to use military courts to pursue cases against citizens, and opposed recent moves to restrict freedom of expression.

### Foreigners withdraw 87pc money from T-bills

KARACHI: Pakistan witnessed 87 per cent foreign investment withdrawal from treasury bills (T-bills) due to a sharp reduction in profit rates in almost seven months. The returns on T-bills halved during the first seven months of the current fiscal year.

### New procedures to bridge sales tax collection gap

ISLAMABAD: The Federal Board of Revenue (FBR) issued new procedures on Wednesday to streamline licensing, issuing electronic sales tax invoices, and integrating registered persons into the electronic invoicing system.

### Petroleum prices may see another fortnightly rise

ISLAMABAD: High-speed diesel (HSD), petrol and kerosene are estimated to increase by up to Rs6 per litre on Friday for the next fortnight owing to higher international prices.

#### Pakistan faces annual loss of Rs5tr in maritime sector

ISLAMABAD: Pakistan faces an annual loss of almost Rs5 trillion (Rs5,000 billion and \$18 billion) in the country's maritime sector because of under-utilised ports, tax evasion, malpractices, fake billing, misuse of Afghan Transit Trade and lack of value addition.

### President, PM, interior minister greet President Xi on Lunar New Year

ISLAMABAD: President Asif Ali Zardari and Prime Minister Shehbaz Sharif have conveyed their heartfelt felicitations to the President of People's Republic of China Xi Jinping on the auspicious occasion of Chinese Spring Festival and the advent of the Year of the Snake.

## Pakistan eves \$100bn investment for 'green energy revolution'

ISLAMABAD: Pakistan will need \$100 billion in investments to fully implement its ambitious renewable energy policies aimed at promoting renewable energy, reducing carbon emissions and transitioning to a sustainable energy future.

## NA panel alarmed over EU's increasing complaints on rice shipments

ISLAMABAD: The National Assembly's Standing Committee on Commerce has expressed deep concern over the recent disruptions in Pakistan's rice exports, particularly following 72 complaints lodged by the European Union regarding the quality of shipments.

## Chinese company to invest \$340m in EV manufacturing, charging stations in Pakistan

KARACHI: A significant development for Pakistan's economy is on the horizon as a Chinese group has announced an investment of \$340 million to set up electric vehicle (EV) manufacturing and charging stations across the country.

### **HSD** imports cross 1m tonnes as demand surges

KARACHI: Pakistan imported over one million tonnes (MT) of high-speed diesel (HSD) in the first half of the current fiscal year, driven by a surge in demand. According to data compiled by the oil industry, the country imported 1.1MT of HSD during July-December of this fiscal year as diesel demand recovered significantly.
