Nepra approves power tariff hike, fixed charges for consumers

ISLAMABAD: The National Electric Supply Company on Thursday approved a federal government motion to increase electricity tariffs by up to Rs8.04 per unit and impose fixed charges of up to Rs1,250 per month on various consumer categories starting July 1, 2024.

Flour millers on strike against withholding tax

Govt raises Rs442bn in T-bill auction, yields fall by 10-18 bps

The government exceeded expectations by raising Rs442 billion through the auction of market treasury bills (T-bills), well above its initial target of Rs150 billion. The auction results, released by the State Bank of Pakistan on Wednesday, also revealed a slight decrease in yields across short-term papers.
