Trade talks: Pakistani officials coming next week: US resident

WASHINGTON: US President Donald Trump said on Friday representatives from Pakistan are coming to the United States next week as the South Asian country seeks to make a deal on tariffs.

Petrol price increased, diesel's unchanged

ISLAMABAD: The price of petrol has been increased by Rs 1.00 per litre to Rs 253.63, effective from June 1, 2025, as announced by the Finance Division on Saturday. However, the rate for high-speed diesel (HSD) will remain stable at Rs 254.64 per litre for the next two weeks.

Ogra slashes LPG prices for June

ISLAMABAD: In line with a decline in oil prices globally, the Oil and Gas Regulatory Authority (OGRA) has issued a notification for the reduction in LPG prices for June 2025. The OGRA has reduced the price of a domestic LPG cylinder by Rs55 and a commercial cylinder by Rs210.

ST, Federal Excise Return: FBR extends date of submission upto June 5

ISLAMABAD: The Federal Board of Revenue (FBR) has extended date of submission of Sales Tax and Federal Excise Return for the tax period of April, 2025 upto June 5, 2025. This is subject to the condition that due sales tax liability has been deposited within due date.

K-Electric urges govt to take control of 300 loss-making feeders

KARACHI: K-Electric wants the government to take control of 300 loss-making feeders, out of a total of 2,129, to make the city load-shedding-free, following criticism from government quarters, including the National Assembly's Standing Committee.

PTBA for extending e-integration deadline

ISLAMABAD: Following failure of the FBR to integrate sales taxpayers, Pakistan Tax Bar Association (PTBA) has asked the Federal Board of Revenue (FBR) to extend the deadline up to June 30, 2025 for corporate sales taxpayers to electronically integrate with the FBR's system.

Gold prices decline further

Gold prices continued to fall on Saturday as world market further lost momentum, sliding under \$3,300 per ounce, traders said. Local gold prices went down by Rs1,400 per tola and Rs1,200 per 10 grams following a decline in world bullion rates by \$14 to sell at \$3,288 per ounce.

Modest business activity on cotton market

LAHORE: The local cotton market on Saturday remained steady and the trading volume remained low. Cotton Analyst Naseem Usman told BR that the current cotton prices in Sindh and Punjab is in between Rs 16,500 and Rs 17,500 per maund, depending on quality and payment.

Petrol price up by Re1, LPG rate reduced

ISLAMABAD: The government has almost maintained the prices of key petroleum products, with the exception of Re1 per litre increase in the petrol price, for the next fortnight.

July-May collection falls short by Rs1tr
