Dar for bilateral lenders debt restructuring — with or without IMF

ISLAMABAD: With or without the IMF, Pakistan would go for debt restructuring of its foreign loans with bilateral lenders, declared Finance Minister Ishaq Dar on Saturday while unveiling the country's plan to get a breathing space in the wake of dwindling foreign exchange reserves.

Sindh govt unveils deficit budget with Rs2.247tr outlay

KARACHI: The Sindh government on Saturday proposed a deficit-budget outlay of Rs2,247.581 billion with a deficit of Rs37.795 billion for the FY2024. It also increased the salaries of public employees by 35 percent for grades 1 to 16 and by 30 percent for grades 17 and up as well as raising pensions by 17.5 percent.

New Customs Duty rates of AIDEP, hybrid electrical vehicles

ISLAMABAD: In the federal budget, one percent duty was imposed on the import of such hybrid electrical vehicles which the manufacturers or local assemblers will import in the shape of completely built unit with quota determination certificate of Engineering Development Board.

Customs duty abolished on lithium battery parts, DC fans, breakers

ISLAMABAD: Customs duty on lithium battery parts, DC fans and breakers has been withdrawn from July 1. According to FBR officials, the exemption will be available to local assemblers and manufacturers through the IOCO.

Higher interest rates help SBP project profits of Rs1.113 trillion: analysts

KARACHI: The government's projection of central bank profits of Rs1.113 trillion for the next fiscal year is reasonable and attainable, analysts said on Saturday, given growing income from lending to the state as a result of higher interest rates.

Fitch says Pakistan unlikely to devalue rupee as pressure eased

Manila: Pakistan, which is negotiating to restart a \$6.7 billion bailout with the International Monetary Fund, is unlikely to devalue its currency again as pressure on the rupee has eased, according to Fitch Ratings.

Gold drops Rs2,050/tola

KARACHI: Gold prices in the local market dropped by Rs2,050 per tola on Saturday. According to All Sindh Saraf Jewellers Association, gold rates in the local market moved down to Rs227,250 per tola. Similarly, the 10-gram gold price also decreased by Rs1,758 to Rs194,830.

Sindh unveils Rs2.2tr development-oriented budget

KARACHI: The Sindh government on Saturday presented a Rs2.2 trillion budget, with a deficit of Rs37.79 billion for the financial year 2023-24. An amount of Rs700.1 billion has been allocated for development projects, focusing especially on rehabilitation of flood-affected people and providing social protection to the poor people of the province.

Sindh aims to collect Rs469b

KARACHI: The Sindh government has unveiled its budget for the next fiscal year, aiming to collect revenue of Rs469.90 billion in provincial taxes. The government has set an ambitious target for itself despite the prevailing economic slowdown. The share of provincial taxes in the total tax receipts is estimated to be around 21%, which amounts to approximately Rs2.20 trillion for FY24.
