ISLAMABAD: The Oil and Gas Regulatory Authority (Ogra) is conducting a public hearing at Lahore on Monday (today) on the petition of Sui Northern Gas Pipelines Limited (SNGPL) for the determination of its estimated revenue requirements/prescribed prices for fiscal year 2024-25. The petitioner (SNGPL) has projected average prescribed price Rs 4,446.89 per MMBTU including previous years' shortfall, in natural gas business.

The All Pakistan Textile Mills Association (APTMA) complains of increased production costs due to an unbearable rise in energy and basic interest rates compared to their regional competitors, yet the government consistently ignores their pleas.

Hearing on SNGPL's '147pc' tariff hike plea today

LAHORE: The Oil and Gas Regulatory Authority (Ogra) is all set to hold a public hearing in Lahore today (Monday) on a petition by Sui Northern Gas Pipelines Limited (SNGPL) seeking another 147 per cent increase in gas tariffs. As the company has requested an increase of Rs2,646 per mmBtu with a request to fix the new price at an average rate of Rs4,446.89 per mmBtu, it estimates a revenue shortfall of over Rs189 billion.
