Law promulgated for sudden tax recovery

The federal government Saturday promulgated, "Tax Laws (Amendment) Ordinance, 2025" for immediate/ sudden recovery from taxpayers' bank accounts or other movable/ immovable properties and sealing of business premises after the decision from higher courts without any further notices.

FBR begins action against companies

The proposal includes fines of Rs. 5,000 for motorcyclists, Rs. 10,000 for cars, Rs. 20,000 for buses, and up to Rs. 25,000 for heavy vehicles.

KARACHI: A windstorm is expected to sweep through Karachi Division on Monday evening, accompanied by isolated light rains, the Met Office said on Saturday, warning about gusts may cause destruction to loose structures and installations.
