### NA body informed: ST imposition at import stage under EFS likely

ISLAMABAD: Federal Board of Revenue (FBR) Member Inland Revenue Najeeb Ahmad on Thursday disclosed before the National Assembly Standing Committee on Finance that the sales tax is likely to be imposed on the import of raw materials/inputs used in the export of finished goods under the Export Facilitation Scheme (EFS) in coming budget (2025-26).

## **High-potential consumer items**

ISLAMABAD: The government is reviewing additional revenue generation measure to impose Federal Excise Duty (FED) on high-potential consumer items including confectionery products (cakes/sweets), sauces, biscuits and other confectionery items.

ISLAMABAD: Pakistan's recent economic turnaround is being seen as a "globally recognised model" of reform, World Bank Managing Director of Operations Anna Bjerde said on Thursday, praising Prime Minister Shehbaz Sharif's leadership for "turning the impossible into possible."

### Forex reserves exceed \$16bn mark on IMF tranche

KARACHI: Pakistan's total liquid foreign exchange reserves rose by \$1.034 billion during the last week, supported by the release of a loan tranche by the IMF.

## Captive power plants to pay levy for natural gas consumption

ISLAMABAD: The National Assembly on Thursday passed Off-the-Grid (Captive Power Plants) Levy Bill 2025 binding every captive power plant using natural gas to pay to the federal government a levy on consumption of natural gas or RLNG.

ISLAMABAD: Prime Minister Muhammad Shehbaz Sharif is set to embark on a significant diplomatic tour of three brotherly Islamic nations — the Islamic Republic of Iran, the Republic of Turkey and Azerbaijan — from May 25 to 29.

### PIA announces weekly flights to Paris from June 18

LAHORE: The Pakistan International Airlines (PIA) has announced the launch of a new direct flight route connecting Lahore to Paris, with the inaugural flight scheduled to depart on June 18.

### Nepra criticises K-Electric over prolonged loadshedding

ISLAMABAD: The power regulator on Thursday expressed disappointment over the hours-long loadshedding in Karachi, disagreed with K-Electric's "immature" explanation, and termed it "out of touch" with the worsening ground realities during a public hearing on the company's March fuel charges adjustment request.

#### **OICCI** asks government to slash tax rates

ISLAMANAD: While unveiling improvement in Business Confidence Survey, the Overseas Investors Chambers of Commerce and Industry (OICCI) asked the government to bring down tax rates of Super Tax, Corporate sector and General Sales Tax (GST) in the coming budget.

# SBP forex reserves hit four-month high of \$11.45bn on IMF tranche

KARACHI: Pakistan's central bank's foreign exchange reserves rose to a four-month high of \$11.446 billion as of May 16 after receiving the second tranche of \$1.023 billion from the International Monetary Fund (IMF) under a \$7 billion loan programme last week, the State Bank of Pakistan (SBP) said on Thursday.

### Withdrawal of zero-rating on EFS imports key to protecting local textile industry

ISLAMABAD: While reinstating zero-rating on local supplies under the Export Facilitation Scheme (EFS) appears highly unlikely given Pakistan's current commitments to the International Monetary Fund (IMF), eliminating zero-rating on imports under the same scheme would align fully with IMF programme objectives and may be the only viable policy correction to protect the domestic textile sector.

## **Exporters face double tax blow**
