MYT regime: Nepra unveils KE's 7-year D&T tariffs

ISLAMABAD: The NEPRA has announced K-Electric's distribution and transmission tariffs for a seven-year period (FY 2023-24 to FY 2029-30) under the Multi-Year Tariff (MYT) regime. NEPRA has estimated a revenue requirement of Rs 50.284 billion for the distribution system for FY 2024-25, approving an average tariff increase of Rs 3.31 per unit.

Tax ordinance will be reviewed, SAPM tells FPCCI
