SBP forex reserves rise by \$70m to \$11.52bn

KARACHI: The State Bank of Pakistan's foreign exchange reserves increased by \$70 million to \$11.516 billion in the week ending May 23, the central bank said on Thursday. However, the total liquid foreign reserves held by the country dropped by \$12 million to \$16.637 billion.

Pakistan launches first sovereign green sukuk

KARACHI: The government, with strategic support from Meezan Bank and the Pakistan Stock Exchange (PSX), has launched its first sovereign green sukuk, marking a significant advancement in sustainable and Sharia-compliant public financing, a statement said on Thursday.

Crypto currencies use is illegal, NA panel told

Govt mulls 1.5% tax on imports
