GCC, Pakistan sign FTA

ISLAMABAD: The Pakistan and Gulf Cooperation Council (GCC) are said to have signed "face saving" Free Trade Agreement (FTA) as both sides have not yet agreed on zero duty on many items, well-informed sources told Business Recorder.

Cut in rates of petroleum products

ISLAMABAD: Interim government on Saturday announced a reduction in the prices of petroleum products up to Rs 11 per litre for first half of October, 2023. In a late night statement, Finance Division announced a reduction of Rs 8 per litre in ex-depot price of petrol and Rs 11 per litre reduction in the price of high speed diesel (HSD) with effect from October 1 to 15.

11.8-kg LPG cylinder: OGRA notifies Rs246.15 price increase for October

ISLAMABAD: The Oil and Gas Regulatory Authority (OGRA), on Saturday notified 8.7 percent or Rs246.15 increase in 11.8-kg domestic LPG cylinder for October 2023 ahead of winter. Giving reason, the regulator stated LPG producer price is linked with Saudi Aramco-CP and US dollar exchange rate.

IT return filing deadline extended to Oct 31

ISLAMABAD: The FBR has extended the last date for filing of income tax returns up to October 31, 2023. In this connection, the FBR has issued an income tax circular number 4 of 2023 late Saturday night.
