'Tax rich more,' IMF asks govt

NEW YORK: International Monetary Fund (IMF) Managing Director Kristalina Georgieva has called on the authorities in Pakistan to charge more taxes from the rich and protect the poor people. Talking to a Pakistani TV channel after holding a meeting with caretaker Prime Minister Anwaar-ul-Haq Kakar on the sidelines of the UNGA in New York, the IMF chief said she believed that was in line with what the people of Pakistan would like to see for the country.

<u>GST evaded through flying invoices estimated at Rs5-6trn</u></u>

ISLAMABAD: The estimated sales tax amount evaded through the fraudulent use of flying invoices (irrelevant invoices) would be approximately Rs 5-6 trillion. Sources told Business Recorder that the use of fake/flying invoices to commit sales tax fraud has increased after facilitation, automation and easy ways to get sales tax registrations.

Minister, retailers discuss steps aimed at boosting exports

Forex reserves rise

KARACHI: The country's total liquid foreign exchange reserves increased by \$ 108 million to \$ 13.187 billion as of September 15, 2023. During the week under review, SBP's reserves increased by \$ 56 million to \$ 7.695 billion.

THE RUPEE PKR strengthens further

KARACHI: The Pakistani rupee continued to appreciate for the 12th successive session against the US dollar, gaining 0.38% in the inter-bank market on Thursday. As per the State Bank of Pakistan (SBP), the rupee settled at 292.78 after an increase of Rs1.1 in the inter-bank market.

Cotton spot rate loses Rs200 per maund

LAHORE: The Spot Rate Committee of the Karachi Cotton Association (KCA) on Thursday decreased the spot rate by Rs 200 per maund and closed it at Rs 18,800 per maund. The local cotton market remained bearish and the trading volume remained satisfactory.
