Govt eyes Rs450b in tax via digital tracking

ISLAMABAD: In an effort to achieve this fiscal year's overambitious tax target, the government has decided to collect Rs450 billion through enforcement measures by aiming to digitally capture Rs48 trillion in services sector supplies over the next three months.

Fed rate cut boosts Pakistan's prospects

KARACHI: Pakistan is poised to benefit from the recent 50 basis point cut in US interest rates, which is expected to stimulate demand in key export markets such as the US and Europe. The Federal Reserve's reduction to a range of 4.75-5% marks the first monetary easing in four years and is projected to boost Pakistan's textile exports, particularly to Western markets.

Trade fair boosts economic ties in Shaanxi province

XI'AN: Just days before China celebrates its 75th anniversary, Xi'an, the capital of Shaanxi Province, witnessed a significant boost in Pakistan-China economic cooperation. The China (Shaanxi)-Pakistan Economic and Trade Cooperation Fair, held in tandem with the Silk Road International Exposition on Friday, saw participation from around 40 Pakistani public and private companies eager to explore investment opportunities with Chinese partners.

Minister hosts talks with Chinese oil firms

ISLAMABAD: Federal Minister for Petroleum, Musadik Malik, led high-level discussions with Chinese companies at the 8th Silk Road Expo held in Xi'an, China. The talks, held at Pakistan's pavilion, aimed at securing key investments in Pakistan's energy sector, with a focus on joint ventures, according to a press statement released on Saturday.

Pak-Russia ties begin to ease

ISLAMABAD: The recent visit of a Russian delegation to Pakistan has barely thawed the icy relations between the two countries, which had stalled after the PTI government signed only memorandums of understanding (MoUs) but failed to reach any substantial deals.
