Realisation of export proceeds: Towel manufacturers criticise SBP circular

KARACHI: **Syed Usman Ali, Senior Vice Chairman of Towel Manufacturers Association of Pakistan** has expressed deep concern over the issuance of SBP FE Circular No 02 of 2023 wherein the exporters are again left facing a new difficult situation.

Core banking systems: SBP asks banks to submit FERs data

KARACHI: The SBP has asked banks to submit data of Foreign Exchange Returns (FERs) prepared through their core banking systems. In December 2022, all banks dealing in foreign exchange were advised to develop their own information set up in core banking systems/solutions for the reporting of monthly FERs through such systems/solutions with effect from May 2023 dataset by 4th of the following month.

THE RUPEE: PKR recovers some ground

KARACHI: A day after plunging to an all-time low, the Pakistani rupee recovered some ground against the US dollar, appreciating 0.63% in the inter-bank market on Wednesday. According to the State Bank of Pakistan (SBP), the local currency settled at 286.62, an increase of Rs1.81.

<u>Duties/taxes-free vehicles import: FBR proposes changes in motor vehicles rules</u>

ISLAMABAD: The Federal Board of Revenue (FBR) has made it mandatory for Customs officials to communicate particulars of the tourists, who have temporarily imported duties/taxes-free vehicles into Pakistan, to the Federal Investigation Agency (FIA).

Higher inflation: Hike in NSS profit rates unlikely to attract investors

ISLAMABAD: The recent increase in profit rates of savings accounts is unlikely to attract investors to products on sale in National Savings Schemes due to high inflation in the country.

KE keen to purchase power from LEPCL

ISLAMABAD: K-Electric (KE) has shown an interest in purchase of power directly from 600-MW coal-fired power plant of Lucky Electric Power Company Limited (LEPCL) as part of its of strategy to improve base load, well informed sources told Business Recorder.

KARACHI: Sindh Chief Minister Syed Murad Ali Shah, presiding over a cabinet meeting at CM House, decided to establish a Sindh Electric Power Regulatory Authority (SEPRA) to improve energy equity and eliminate "energy poverty" in the province.

Gold prices down

KARACHI: Gold prices on Wednesday inched down but silver remained firm on the local market, traders said. Gold prices fell by Rs 300 to Rs 218000 per tola and Rs 257 to Rs 186900 per 10 grams.

Cotton spot rate goes up by Rs200 per maund

LAHORE: The Spot Rate Committee of the Karachi Cotton Association on Wednesday increased the spot rate by Rs 200 per maund and closed it at Rs 19,500 per maund.

PPP demands removal of minister over gas crisis

KARACHI: Just days after Sindh Chief Minister Syed Murad Ali Shah told the federal government that gas loadshedding in the gas-producing province is against the Constitution and demanded an end to the crisis, the PPP on Wednesday called for removal of Minister of State for Petroleum and Natural Resources Dr Musadik Malik and chief of the Sui Southern Gas Company for their poor performance and "false promises".

Discos allowed to extract additional Rs15bn from power consumers

With almost two-thirds of power plants operating at less than 20 per cent utilisation factor, the NEPRA on Wednesday notified ex-Wapda Distribution Companies (Discos) to charge 47 paise per unit to their consumers to mop up Rs15.5 billion in additional funds under the QTA mechanism.

China, India aggressively buying cheaper spot LNG

LAUNCESTON: Cheaper spot prices for liquefied natural gas (LNG) are luring price-sensitive buyers back in Asia, with China and India recording rising imports in March. The spot price of LNG for delivery to north Asia LNG-AS was \$12.50 per million British thermal units (mmBtu) in the week to April 6, steady from the previous week, which was the lowest level since June 2021.

FBR denounced for disclosing identity of whistle-blower

ISLAMABAD: President Dr Arif Alvi on Wednesday censured the FBR for leaking the whistle-blower's identity to the tax-evading private company which allegedly committed financial irregularities.

Slowing US inflation shifts investor focus to earnings season

NEW YORK: Inflation data showing US consumer prices rising less than expected in March may have come as a relief to markets, but some investors believe it may take a strong corporate earnings season to push stocks higher decisively.

Rupee recovers Rs1.8 against dollar

KARACHI: The rupee recovered Rs1.81 against the dollar in the interbank market on Wednesday. The US dollar settled at Rs286.62 from Rs288.43 on Tuesday, reported the State Bank of Pakistan.

We are being unfairly penalised, say exporters
